Basking in 100 Years of LWV-RMA

I've done a lot of new things this year, many of them in my capacity with the League. For example, I've never planned a 100th anniversary before, for anything. Clearly, we needed a big public event to celebrate our history. I get anxious planning big events. It's hard to order supplies when the turnout could vary from a couple of dozen to hundreds.

The great thing is that we're not alone. We have a lot of partners that we work with every year to get out the vote. As we did last year, we began planning with our partners at SEIU and RocACTS, and over time brought in a slew of others, including the Greek letter sororities, the Urban League, the NAACP, the Rochester Black Nurses Association and the Coalition of Black Trade Unionists. There's a lot I don't know about our own history, but I'm pretty sure 100 years ago those groups might not have been our natural collaborators. We persist and we change.

The planning team was big and individuals popped in and out, ideas were thrown around and considered, and we lived with uncertainty. In the end, parts of the planned program evaporated. But through it all, the League showed up, and at the event we showed up. We are a central player in the effort to get marginal voters out of their houses to vote. I don't think we've made the kind of progress that you brag about, but we keep showing up, and that's a tradition worth celebrating. And it was great to have a proclamation from Mayor Evans and County Executive Bello to recognize a hundred years of showing up.

We managed to register a few first-time voters and get them on the shuttle bus to go over to the Board of Elections (BOE) to vote. That's never been possible before this year, and reflects years of lobbying and advocacy success. We had some great entertainment and some food that tasted great on a cool fall day. We had the marching band I've been craving for years, and a mock election for the kids. There was plenty of time to hang out, network, and chat with the team that made the event possible. Though we haven't worked with these particular partners on promoting Prop. 1, I got a lot of thanks for our work on that. It was a good day.

One of my favorite moments came at the end. How to get those door-hangers into the hands of voters? Our friends from the SEIU, who do a lot of door-to-door canvassing were happy to take them off our hands for distribution in our mutual goal of getting out the vote. That's something to be happy with at 100 years: a good party with our good friends, working together to get Monroe County to the polls.

By these Presents, Greetings:

- WHEREAS: The League of Women Voters was founded in Chicago following the passage of the 19th Amendment in 1920 to help women understand and fulfill their new responsibilities as voters; and
- WHEREAS: For 100 years, the League of Women Voters in the Rochester Metropolitan Area has empowered voters and defended democracy, establishing itself as a trusted, nonpartisan grassroots organization; and
- WHEREAS: The League has championed legislation and fought in courts to protect and strengthen voting rights, ensuring access to free and fair elections and civil rights, and promoting a political system where all citizens can thrive; and
- WHEREAS: The League has been recognized for its nonpartisan election information, sponsoring candidate forums, and providing voter guides and vital resources on state and local ballot issues, while educating and mobilizing voters; and
- WHEREAS: The League continues to advocate for open, transparent, inclusive, and equitable government systems, believing that active, engaged citizens regardless of gender, race, national origin, disability, or political affiliation are essential to democracy; and
- WHEREAS: On October 26, 2024, the League of Women Voters in Rochester, in partnership with other community organizations, will celebrate "Golden Day," a day when citizens can both register to vote and cast their ballots, marking a century of dedication to voter education and civic engagement.

NOW, THEREFORE, we, Malik D. Evans, Mayor of the City of Rochester, New York and Adam J. Bello, Monroe County Executive, do hereby proclaim October 26, 2024 to honor and celebrate:

WHAT IS THE VOTER GIRL PROJECT? (from the LWV-Kent Ohio Voter)

"[It] is a fun and rewarding activity in which Leagues collaborate with their local Girl Scout councils. The one-day class is available for all scout levels--from Daisies to Ambassadors--with a curriculum appropriate for each level.

League members use their knowledge of voting and advocacy to help scouts earn citizenship badges that promote the ideals Leagues cherish. A curriculum guide has been developed by teachers and communicators with backgrounds in diversity and elementary and higher education. You receive marketing materials and operation tips that have been tested.

Best of all, scouts bring to the event their curiosity and determination to learn. Your League develops a high-profile community event that draws interest from media, parents and public officials."

The program can be whatever the LWV-RMA volunteers and the local Girl Scout Leaders involved want to make it.

Naturalization Ceremonies

On September 17th at SUNY Brockport, 94 candidates became naturalized American citizens. Marcia Eisenberg and David Newman talked with the new citizens about voting and helped them register to vote.

October 15 had two naturalization ceremonies. Thirty-one new citizens were sworn in at the Monroe County Office Building at 11:00 A.M. with League representatives Beth Feldman and Margret Roberts attending. The 2:00 P.M. ceremony was held at the Federal Building with Marcia Eisenberg and Margaret Supinski representing the League. Marian Paulson officiated at the ceremony with 43 candidates.

Book Review

Represent: The Unfinished Fight for the Vote, by Michael Eric Dyson & Marc Favreau ISBN 978-2-759557062

Written for teens, *Represent* is a history of voting and voter restrictions starting with women's suffrage. Racial discrimination is documented from slavery, the Civil War and the Voting Rights Act to the Edmund Pettis Bridge, as well as by the inability of Native Americans to vote until recently and the Chinese Exclusion Act. Voting activists are profiled. The concluding chapters discuss gerrymandering and current efforts at voter suppression, and encourage activism with specific suggestions.

It is a very clear history and call to arms that is worth everyone's time.

LWV-RMA & WROC-TV8 Present Congressional Debates


