President's Corner

VOTER SUPPRESSION AND INTIMIDATION OCCURS IN NEW YORK STATE.

Below is an article written by Lanning Taliaferro and posted by Patch News on Thursday, Sep 7, 2023. The New York Citizens Audit group referenced in the article has made claims of about 5,000 voter fraud cases in Monroe County at a MC Legislature meeting. These activities discourage people from voting which makes our efforts to encourage voting even more critical. If you hear of them calling on individual voters in Monroe County, please report it to our Board of Elections.

HUDSON VALLEY, NY — The New York Board of Elections is warning that voters across the state are being confronted by people impersonating election officials regarding their registration status, and erroneously accused of committing a crime because of how they appear in the state voter database.

"We are extremely alarmed by these actions. These individuals are impersonating government officials in an effort to intimidate voters based on inaccurate and misleading information," Raymond J. Riley III, Co-Executive Director of the State Board of Elections, said in a statement issued Aug. 30. "We strongly encourage those engaging in these activities to cease immediately."

The state BOE knows that residents were contacted in Albany, Chautauqua, Jefferson, Onondaga, Ontario, Orange, Putnam, Saratoga, Schenectady, Steuben, Suffolk, Warren, and Washington counties, spokesperson Kathleen McGrath told Patch.

"This list may grow, as this is an ongoing situation," she said. "And it's impossible to know how many other incidents may have occurred, where the voter did not alert a County Board or local law enforcement."

The State Board alerted all county boards Aug. 29 and encouraged them to track details of any incidents and report them to local law enforcement. The State Board has passed along information to state and federal law enforcement, as well.

"There have been cases where the voter has been confronted by individual(s) claiming to be from a Board of Elections (some demanding to see the voter's license). The individual(s) have claimed the voter is committing a crime by being registered to vote in multiple places in New York State," she wrote in an email. "In each case we have seen thus far, the voter has been properly registered at their current address, but had an earlier voter registration at a former address in a different county in the state (which has been properly purged by the county, as is the normal process when New Yorkers move from county to county). In other words, the voter only had one active registration in the database, and it was at their current address."

Putnam County Board of Elections Commissioner Cathy Croft told Patch that four residents had called the BOE after being approached. They called because they had become concerned about the status of their voter registration, she said.

"Calls came from all over the county including Philipstown, Carmel and Kent," she said.

State officials said county elections board staffs work year-round to ensure elections are safe and secure, including extensive record-keeping to protect from bad actors — including these.

State officials said a voter approached by someone claiming to be from the state or a county board of elections should immediately request identification. "If the individual refuses or appears under suspicious circumstances, the State Board recommends collecting as much information as possible, not providing the individual with any personal information, and contacting local law enforcement to report the incident."

Criminal impersonation in the second degree is a class A misdemeanor in New York.

"While we note the pattern of activity and believe it to be a coordinated effort, we will leave determining who is responsible for these interactions with voters up to law enforcement," McGrath said.

Although the State Board of Elections did not name any suspected perpetrators, a group called New York Citizens Audit issued a statement Aug. 31 implying that the state could be making a "precipitous and unfounded" announcement that could discourage citizen participation in "legal investigations of election procedures."

The group's executive director told the USA Today network that her group had started "doing field work after state officials failed to act on its allegations about duplicate registrations and more" and insisted her "researchers" were using "lawful methods," the Times Herald-Record reported.

The group's voter fraud allegations were detailed in a March article on syracuse.com, after which the paper's editorial board weighed in with an opinion piece: "NY election 'citizen auditors' are playing a dangerous game."

Turns Out You Can't Go to Jail for Voting

We are sorry to report that the Superintendent of the Monroe County Jail has declined our proposal to come into the jail to assist inmates with registering and voting. The reason given was that he feels the jail personnel are efficiently and effectively making sure that each incarcerated individual has the ability to exercise their right to vote.

He spells out that individuals are notified that they can request a voter registration form or an absentee ballot application form, and details how they are supplied promptly and how individuals fill them out (with assistance if they request it) and can return them either via the mail or by couriers between the jail and the BOE.

That all sounds fine, but we suspect that a little encouragement and outreach would generate more votes than the process described to us.

The good news is that the Jail Administration is willing to vet materials we send them and to pass along educational non-partisan voting videos to each inmate to view on their tablets. So we have our work cut out for us, to find and/or create such videos. If you know of some, please pass them along to Judy Sternberg at <u>justice@lwv-rma.org</u>. Meanwhile, we are scrambling to produce some, as well as an offline version of Vote411.

It's possible that our proposal was too ambitious. For the jail to have allowed our teams to come into residential units would have required a substantial commitment on their part in terms of escorts and security. Perhaps we can propose something smaller, such as an ongoing civic education/discussion program. Stay tuned.

New York State Legislative Update

The following bills were signed by Governor Hochul on September 21th. Thanks to everyone who worked to get this legislation over the finish line!

Voter Services Update

The Voter Services team is focusing their efforts on attending grassroots community events in neighborhoods with historically low voter turnout. Some examples of events attended are:

- Community uplift events organized by Maplewood Neighborhood Association and Charlotte Neighborhood Association,
- Front Porch Festival at Jordan Health Center,
- Greater Harvest Church Pray and Play Events.

The number of attendees at these events is sometimes smaller than at the bigger festivals, but the number of registrations has been comparable. As of September 20, the team has registered 41 new voters at these events. The teams report having good conversations about the importance of voting in the local races this year.

Our "Vote 411" palm cards are well received by people who are already registered. Working with Annette Ramos, a Board of Elections registration coordinator, the LWV-RMA team is covering events for which she does not have staff.

Kim Byers and Barbara Grosh are working with ROCActs to organize "Souls to Polls" around Halloween. The concept is to have a lunch or mid-day picnic at two churches on a Sunday during early voting. From there, people will go as a group to the nearest early voting site to vote. The two churches involved are:

- Trinity Emmanuel Presbyterian Church on Shelter Street
- First Genesis Baptist Church on Hudson Avenue

Members can now sign up to volunteer at these and other events using the LWV-RMA website. This replaces Signup Genius used previously. Myra Pelz and Kim Byers have also created a way for non-members to volunteer at some events on the new system.

We are hopeful that this will attract more diverse volunteers and new members. The site also provides resources for volunteers to learn best practices when registering voters.

Naturalization Ceremonies

September brought the League to three naturalization events. Tamara Minter and Margret Roberts represented the League at an 11:00 AM ceremony on Sept. 12. They helped 38 candidates for citizenship register to vote at the Monroe County Office Building. The new citizens came from 23 countries.

On the afternoon of September 12, Sheila Abeling and Mary Menz helped new citizens register to vote at a 2:00 PM naturalization ceremony. There were 35 candidates for citizenship at the Federal Building with Judge Pedersen officiating.

On September 18, there was a naturalization ceremony at SUNY College at Brockport at 11:00 AM with 83 candidates for citizenship. Joann Kane-DeMott and Marcia Eisenberg represented the League.

Thank you so much to all our League volunteers for helping out at these ceremonies! You are appreciated by the League as well as by the new citizens.



The Time the LWV-RMA Went to the Supreme Court

The LWV-RMA has a long history of supporting the voting rights of people held in the Monroe County Jail. In 1972 Jean Askhom, who has since passed away, was the LWV-RMA Chair of Voter Services. In that role she signed an affidavit in a case brought by 72 men held at the jail against the Monroe County Sheriff and the Commissioners of Board of Elections (BOE).

Prior to 1972, to register to vote in Monroe County, you had to appear in person at the Monroe County (MC) Register's Office. In July 1972 the County Legislature, recognizing that the inconvenient office location and hours prevented people from registering, authorized mobile registration units staffed by volunteers.

Per Jean's affidavit, in August League representatives requested the Sheriff allow them to offer registration services to those held in the jail prior to trial or serving misdemeanors. The request was denied. The League reviewed the matter with the BOE which agreed the men had not lost their voting rights. However, the BOE and Sheriff maintained that since they could not be taken to the polls to vote, there was no need in having them register.

The League proposed having the men utilize the absentee ballot process. However the BOE maintained that being in the jail did not meet the criteria for an absentee ballot.

The League reached out to the people held in the jail and informed them they had not lost their right to vote and collected addresses and other information from those who wished to register and/or vote. The list led to the 72 men named in the lawsuit.

The state trial and intermediate appellate courts initially viewed men's confinement as physical disability and held that they were entitled to vote by absentee ballot. The New York Court of Appeals reversed that determination, concluding that the disability imposed by incarceration did not come within the terms of the statute. The case, known as O'Brien v. Skinner, was then appealed to the Supreme Court.

In January 1974 Chief Justice Burger delivered the opinion of the Court. The ruling states that prisoners who are otherwise legally qualified to vote cannot be denied the right to vote solely because of incarceration. The Court also ruled that if the state provides no other method of voting for the prisoners the statute which excludes prisoners from absentee voting denies them the equal protection of the laws.

Current League member Shirley Eberly, who brought this case to the attention of those currently working on ensuring those held in the jail have voting access, shared this recollection:

"After the ruling by the Supreme Court, another League member and I went to the jail to register prisoners who wished to vote. In those days, we had to have two people to do voter registration--one a Democrat and one a Republican. We each carried a large black suitcase from the Board of Elections. The suitcases contained the registration forms. No one opened them to verify the contents, but we did have to go through a series of locked doors. An interesting experience, to say the least."

Today the LWV-RMA continues to work to ensure the voting rights of the incarcerated are upheld.

LWV-RMA members met via Zoom on September 21 to discuss *The Second Amendment: A Biography* by Michael Waldman. The Second Amendment reads in its entirety: "A well regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms, shall not be infringed."

The book provides a detailed history of how the Second Amendment has been interpreted since its approval in the 18th Century, noting that the amendment was written to calm fears that the new national government would crush state militias whose members were required to own a gun to serve. As the country expanded westward and fought a civil war, violence spread too, but gun control was abundant. In the 20th Century, the first federal gun control laws were passed and upheld by the Supreme Court. For 218 years, judges overwhelmingly concluded that the amendment simply authorized states to form militias (National Guard). It wasn't until the 1970s that the NRA began its campaign against gun control. Then in 2008, in the case of District of Columbia vs. Heller, an opinion of the U.S. Supreme Court written by Justice Antonin Scalia declared that the Constitution confers a right to own a gun for self-defense in the home. So the current interpretation of the Second Amendment is quite recent and politically charged.
