President's Corner

PREPARING FOR THE 2023 ELECTIONS

I read recently that 99% of elected officials are state or local officials. When you consider the million ways local and state governments affect us, it's a great argument for voting in odd year elections. I'm very proud of how much we're doing to make it possible to be an informed voter. It would be hard to consider oneself an informed voter in town, village or county elections based on what one learned even in local media. Vote411 is crucial to voters.

I'm also proud of our work organizing candidate forums. In 2021 I was disappointed that only candidates from one town accepted our invitation, but this year it's four, and there were several forums during the primaries, for seats which are not contested in the general election. So, we are doing a serious job of helping people to be informed voters, and our door hangers remind people what's at stake and how to vote early.

In the past month, I spent a lot of time producing two new videos designed to inform inmates in the Monroe County Jail about the election. They are designed to help incarcerated individuals to understand that they have the right to vote and that it's worth doing so. They answer a lot of questions about the practicalities.

We were optimistic that the jail would share the videos with inmates and that a few might respond by choosing to vote. Alas, we've been informed that the jail will not share them. No reason was given, but we are informed that they complied with "changes to the Correction Law 510(2), requiring the chief administrative officer of any local correction facility to consult with the county Board of Election on the same."

Pre-1972, both the jail administration and the county Board of Elections chose to interpret the law to make it impossible for incarcerated county residents to vote. Following the Supreme Court decision on the case we brought against them, members of LWV-RMA were permitted to go into the jail and register voters. In 2023 the legal precedent stands, but the League is being blocked from doing for those citizens what we do for all citizens in Monroe County, helping them to become informed voters.

It seems the Monroe County Sheriff's Office (MCSO) and the Jail Bureau (JB) are accepting of the letter of the law on providing information and access to voting for eligible incarcerated individuals. We hope we'll be able to help them appreciate how the League can supplement the jail's process - that is by drawing attention to the information they provide and by active encouragement of voting, highlighting its significance and value.

We will be seeking more information on the jail's process and its efficacy, and more utilization of the resources available to us - including our local Board of Elections, the statewide work of LWV's criminal justice team, and our partners in the Monroe County Jail Voting Coalition. Stay tuned. We're not done.



Souls to the Polls

The League of Women Voters-Rochester Metro Area, in collaboration with RocACTS, has implemented a new "Get Out the Vote" (GOTV) program. Modeled after similar programs in Southern states, Buffalo, NY and Niagara Falls, NY, we are facilitating "Souls to the Polls" for the first time. This program is tailored to draw people to vote through a welcoming, encouraging, community effort.

With the engagement of local churches, their pastors and congregants, as well as local businesses and community centers, LWV-RMA is working to encourage the neighborhood to be a part of the democratic process. For the inaugural program, two churches are serving as the base for the "2023 Rochester Souls to the Polls". At each site, shuttles will be available to provide round-trip rides to the closest early voting site. A free lunch/dinner will be provided along with entertainment.

The churches that will be the "Souls to the Polls" base locations are in two of the lowest voter turnout districts in Rochester and both churches support ministries to address food insecurity in the neighborhood. The churches are:

- First Genesis Baptist Church at 292 Hudson Avenue, Rochester on Sunday, October 29th
- Trinity Emmanuel Presbyterian Church at 9 Shelter Street, Rochester on Sunday, November 5th

Food will be prepared to serve the first 100 people at each site. If we have more than 100 people, we will provide a small food take-away that include a \$5 gift certificate to a nearby eatery (e.g., McDonalds) as well as snacks such as granola bars and peach cups.

Thanks are due to all our LWV and RocACTS volunteers and to our sponsor churches, which have opened their doors and facilities to this pilot program. In addition, we are fortunate to have partnerships with the following:

- University of Rochester: Donation of shuttle bus and driver at Trinity Emmanuel Presbyterian Church
- **University of Rochester students**: Volunteers to distribute flyers and door hangars in the Trinity Emmanuel neighborhood.
- 1199 SEIU Healthcare Workers East: Donation for shuttle bus at First Genesis Baptist Church
- **Alumni Chapter of Delta Sigma Theta Sorority**: Volunteers to distribute flyers and door hangers in the First Genesis neighborhood.
- **Zeta Phi Beta Sorority**: Volunteers to assist with meal service at Trinity Emmanuel Presbyterian Church.

With music and line dancing, our goal is to energize the neighborhood and increase voter turnout. This collaborative community event is a new approach to "Get Out the Vote" for Rochester and is hopefully just the beginning of increasing turnout in these neighborhoods.

Voter Services

It's been a busy month for Voter Services. We registered voters at both campuses of Monroe Community College, the Hispanic Heritage Celebration and the Hall of Justice Career Fair. We plan to be at Cameron Community Ministries later in October.

We distributed over a hundred of LWV-RMA door hangers to those many people we encountered who are already registered to vote. Most of those people are not aware of the opportunities for voting early, and they appreciate a short, easy-to-read reminder. All of these events are a team effort and we thank the members and non-member volunteers who have made it all possible. We continue to refine our procedures and support for volunteers. We are updating materials and tracking volunteer feedback about which events are most successful so we can be most effective in the future.

On October 19th and 24th Katherine Smith, Katie Powell and Theresa McFarland-Porter teamed up to visit the Participation in Government classes at the School of the Arts (SOTA). In this collaboration with SOTA's social studies teachers we're working to energize and inspire new voters.

As guest teachers, we build an interactive timeline illustrating the fight for the vote and then we invite students to become part of that history and register. Margret Roberts provided Jolly Rancher candies which were fun motivators when the kids were asked to physically move during the timeline creation. Debora Gordon provided paper slips with a QRC code that the students could use to check their registration status. It's a fun and productive gig! We registered 54 students during the program!

Redistricting Team Update

The process continues. This is where things stood on October 17th.

MONROE COUNTY LEGISLATURE: A lawsuit was filed to challenge the new county legislature districts. The suit was dismissed in August, and no appeal was filed. The districts will remain as is.

US HOUSE OF REPRESENTATIVES: In mid-July, the New York Appellate Division ruled that the Independent Redistricting Commission (IRC) should draw new Congressional districts – again. The new districts would take effect for the 2024 elections. An appeal has been filed with NY's highest court, the Court of Appeals. A hearing is scheduled for November 15th.

Meanwhile, the court directed the IRC to work on the new map. The Commission announced that no new hearings will be held prior to drawing the map, but written input is welcomed.

New York State Ballot Proposals

Two proposed changes to the NY State Constitution are on the ballot for the November 2023 election. The proposals address rather obscure issues that most people are unaware of. Therefore, the proposals are a bit difficult to understand at first glance. A forum was sponsored by LWVNY and the Delta Sigma Theta Sorority to explain the proposals. Below is a summary of the key points from the forum and a link to the Zoom presentation.

Proposal 1: This relates to the debt limit for certain New York School Districts.

The debt limit is the % of the taxable property base schools are allowed to borrow. For example, if all the taxable properties in a district have a total value of \$1,000,000 and the debt limit is 10%, the schools debt limit is \$100,000.

Currently the NYS Constitution states that the Small City School Districts have a debt limit of 5%, while larger cities are 9% or 10%. There are approximately 57 districts that are in the small district category. Additionally, this group of districts cannot reduce the "debt" used in the calculation by the amount of state aid they will be receiving for the project. The other districts do not include the funding from the state as debt.

Therefore larger districts can borrow significantly more money than smaller districts even if the two districts have the same total taxable base.

When these rules were put in place, many of the Small City School Districts did not hold budget votes. Therefore the limits were set lower to protect the property owners. However, since the 1980's budgets have been voted on in all districts.

There is no group opposing this proposal, which is designed to bring equity between school districts.

Proposal 2: This relates to how major sewer projects impact a town or city's debt limit.

In 1973 the State Constitution was modified to exclude the money borrowed to complete major sewer projects from the debt limit calculations. However, the exclusion was only good for 10yrs. The 10 year limit was included to encourage communities to make the investments quickly. However, since major sewer projects continue to be needed, every 10 years voters are asked to extend the exclusion for another 10 years. Ending the exclusion could prevent communities from making necessary sewer improvements. There is no group opposing this proposal.
