

Celebrate 100 Years of LWV-RMA at an Early Voting Celebration

As of 2024, our local League has been active for 100 years. When I realized that last year, I thought we needed to plan a suitable celebration of all the work we've done and continue to do. That celebration will be happening at Parcel 5, on October 26 from noon - 3:00 P.M.

The 26th is a wonderful day to gather, because it is the first day of early voting, as well as the last day to register for the general election. The first day of day of early voting has been labeled the Golden Day. The Flower City Pride Band will help warm the crowd up with some marching-style music and whoever wishes can march together to the County Office Building which is 4/10 of a mile away. We'll also have a shuttle bus making loops between the park at Parcel 5 and the Board of Elections offices so that people can easily vote throughout the party.

There will be food trucks (free food for the first 200 people), hot beverages, music, a host, children's choirs and performers, line dancing, and more. Everyone will receive an "I Voted" sticker bearing the winning design from our contest. There will be face-painting and a photo booth and kids will be casting ballots in a mock election. Several churches will be helping us by transporting people from their neighborhoods to the park. Two different radio stations are helping to promote the event, and you should be seeing it on early morning local news shows (if you're the kind of person who gets up early).

I'm super happy with the wonderful partners we're working with to make this event happen this year, and hopefully again every year. They include SEIU, RocACTS, the NAACP, several of the Divine Nine sororities and fraternities, Vocal-NY, the National Association of Black Nurses and the Coalition of Black Trade Unionists. It's a tribute to our hard work and networking throughout the Rochester community to be working with these great groups.

Help Educate the Next Generation of Informed Voters and Future Members of the LWV-RMA



The LWVUS and the Girl Scouts of the USA (GSUSA) are teaming up to build civically engaged girls of courage, confidence, and character. This will be a great opportunity to acquaint young girls and women with LWV-RMA and to provide education and experiences to reinforce civic responsibility.

- Girl Scouts' Civics Badges: Partner to help Girl Scouts earn badges related to civics and democracy.
- Co-Host Events: Local Leagues and Girl Scout councils or service units co-hosting educational events, badge workshops, and voter registration drives.

This program can be whatever the LWV-RMA volunteers and the local Girl Scout Leaders involved want to make it.

This is a great opportunity for LWV-RMA to help educate future voters and encourage future membership in our organization. We will miss this opportunity without a core group of members willing to work with the local Girl Scout leadership to organize and maintain the collaboration.

New York State Election Security

This information from the NYS Board of Elections website and the Monroe County Board of Elections (BOE) will address any concerns you, or voters you interact with, may have about the validity of the elections.

Bipartisan Teams: New York is one of 10 states where all facets of elections are conducted by bipartisan teams. This extends from the state Commissioners to the County Boards of Election to all functions at each polling place.

Ensuring only eligible citizens vote: When registering someone to vote, the Board of Elections checks the identity of the voter, through the voter's provided DMV number (driver's license number or non-driver ID number), or the last four digits of their social security number.

If the voter does not have a DMV or social security number, they may use some other government document that shows their name and address.

If the Board is unable to verify a voter's identity before Election Day, they will be asked for ID when voting for the first time.

Machine testing and security: Before any voting system is eligible for purchase in New York State, it must meet the strict requirements.

Notable security measures include:

- A protective counter which records the number of times the
 machine has been operated since it was built and a public counter
 which records the number of persons who have voted on the machine at each separate election;
- A lock which will absolutely secure the voting or registering mechanism and prevent the recording of additional votes;
- Prohibiting any device or functionality potentially capable of externally transmitting or receiving data via the internet or via radio waves or via other wireless means.

Pre-Election Audit: At least annually, County Boards of Election test each machine. Tests include verification of the programming and recording of votes to determine if such machine accurately records such votes.

At polling sites: Each polling site is overseen by both a Republican and a Democrat Site Chair who both must sign paperwork confirming that all activities were performed in accordance with guidelines. Bipartisan teams of poll workers work together to 1) set up ballot machines ensuring that each starts with 0 ballots recorded; 2) sign voters in, ensuring they are registered and that they provide ID if required; 3) provide the correct paper ballot and instructions; and 4) monitor the voting machines (without touching ballots).

At the end of the night a bipartisan team 1) prints and signs reports from each machine showing the total ballots cast for each candidate; 2) removes one machine memory card and puts it in a locked bag for transport to the BOE and ensures the other card is sealed in the machine; 3) accounts for all paper ballots provided to the site. The ballots are transported (in sealed bins) to a location separate from the place where the memory card and printed reports are delivered.

Post-Election Audits: Within 15 days after each general or special election, within 13 days after every primary election, and within 7 days after every village election conducted by the Board of Elections, the BOE audits the records from three percent of voting machines.

Each impacted candidate, political party or independent body is entitled to appoint watchers to observe the audit.

How Can I Get a Sticker?

The League will print a few thousand stickers. They will be available to all at Roc the Vote, a community celebration of voting on October 26. Meet at Parcel 5 downtown from Noon - 3:00 P.M. Enjoy music, DJ's entertainment, food, face painting, and the chance to cast your vote nearby. SPECIAL NOTE: On October 26 only, you can register to vote and then cast your vote, both at the same time.

You might find them at other locations, such as the mock elections at MCC and perhaps on Election Day at Mount Hope Cemetery at Susan B Anthony's grave. If you have a great idea for where to distribute them, share your thoughts by sending a message to stickers@lwv-rma.org.

What is Ranked Choice Voting?

In Ranked Choice Voting, each voter ranks all the available choices. This is important whenever there are more than two choices, because it avoids the possibility of one candidate winning with a minority of the votes. If no one gets a majority of votes after the first round of voting, the candidate with fewest votes is eliminated, and their ballots are reallocated to those voters' second choice. This process continues for as many rounds as it takes to get a winner with a majority of votes.
