Only You Can Avert Constitutional Crises

When I took office as President of the League in 2021, I knew that by June of 2025 I'd be done. It's right there in Article 4, Section 1 of the by-laws: "No officer shall be eligible for election to the same office for more than two (2) full consecutive terms, up to 4 full years." I think it's a great principle.

So why am I running for president for an additional year? I'm creepily reminding myself of our current US president who seems to spend a lot of time plotting how to stay on beyond his constitutionally-limited term. I don't think either him or me overstaying is a good thing.

I'm running for an additional half term because the Nominations Committee couldn't find anyone with the requisite skills who was willing to take on the presidency. Let me spell that out a little. The president is the spokesperson for the League, so we need someone who's not afraid of public speaking and knows the culture of the League well enough to speak in the nonpartisan yet no-nonsense way the League speaks. The president runs the monthly board meetings, which means s/he has to have a decent understanding of what we do in a year. The president feels responsible for the League holding together and getting stuff done, which either implies good organizational and interpersonal skills and/ or a willingness to pitch in and do what s/he sees needs doing in a pinch.

The keys to making the presidency something people are willing to take on (in my humble opinion) are:

- Build committees that do the vast majority of the work with minimal supervision
- Build on-ramps where people acquire and appreciate League culture

We have a whole raft of talented new and less-new members who could really contribute to a lively local League, one where a new president will quickly emerge.

What do you want to do to make democracy work?

If you don't know how to get involved, talk with a committee chair or member, with me or another board member, or with Kim Byers, membership chair. We will help you find the niche where your skills will make us a vibrant League and you will acquire the knowledge to become a League leader, if you like that sort of thing.

League-member interests is what determines what a League does. We are good at lobbying our Senators and Assembly members on state issues of League interest. Not every League does. We have members who are patient and diligent about registering voters in low-turnout parts of the city. Not every League does. Other Leagues do other things: some are co-programming with the Girl Scouts to build civic knowledge engagement in our youth. Until someone here is willing to step up, we won't. We have members who feel driven to help get out the vote in red states with voter suppression: we have sent thousands of post-cards to help people vote. We are currently reaching out to two local demographic groups with low voter turnout: 18-year olds and New Americans.

What's on your mind? And what do you know how to do? Could you help plan educational forums for our members and the wider community? Help maintain the website or send out the emails? Run zoom events? We need a lot of hands to make a vibrant League.

The board briefly entertained amending the by-laws to allow officers to stay on longer so that my next year will not be illegal. I vetoed it. We have a strong incoming board and I see new leadership emerging, permitting old leaders like me to have a rest while others' leadership blossoms. You can help make that happen.

LWV-RMA has an opportunity to send 6 delegates to the State Convention held in Albany. The convention will kick off on Friday, June 20th at 5:00 P.M. with Celina Stewart, Chief Executive Officer of the League of Women Voters of the United States. The convention will end on Sunday June 22 at 12:00 P.M.

Delegates representing the local Leagues come together to make the important decisions that will guide LWVNYS through the next two years including the election of officers and directors, and the adoption of a budget, bylaws amendments, and our state program for 2025-2027.

There will be workshops on various topics including Tools to Get Out the Vote, Building Membership, Pushing Back, and DEI. Various Leagues will showcase their initiatives. Delegates will vote on proposed positions including those on Ranked-Choice Voting and Nonpartisan Primaries.

The convention is an opportunity:

- to meet and network in person with League leaders from all over the state
- to make new friends and renew old friendships
- to collaborate and tackle the challenges we all face

The Outreach to New Americans Committee

The Outreach to New Americans Committee met twice in April to begin our work to "help new Americans feel more motivated and more prepared to vote," as our chapter's President Barbara Grosh noted in the March 2025 newsletter. We started this initiative because data from the Board of Elections show that new citizens rarely exercise their right to vote, even though they are registered.

The Outreach to New Americans Committee met on April 5th to brainstorm strategies and

sites where we could connect with new voters.

Over the next few weeks, we drew up some talking points as a guide to "pitch" our message and identified about a dozen community groups and organizations to begin our outreach. At our meeting on April 17th we divided up the groups and organizations for initial phone contact by Committee members. We also discussed ways to follow up with new citizens closer

to elections to provide more timely information and encouragement.

Fight Climate Change:

The Inflation Reduction Act and Savings for Homeowners

John Smillie will discuss the Inflation Reduction Act and the provisions that make it a powerful bill for fighting climate change, with a focus on the tax credits and rebates available to homeowners for electrifying their own lives.

John Smillie lives mostly in Crawfordsville, Indiana, where over the past several years he has served as a Congressional Liaison for his local chapter of Citizens' Climate Lobby, as well as the chair of the Climate Team for his local LWV chapter.

He has made significant progress electrifying his own home in Indiana, and has been featured in <u>Canary Media</u> for his philanthropic work bringing solar to local nonprofits, and in <u>Bloomberg</u> for being an "energy nerd".

the new voting procedures.

Our table was a public show of support for this non-partisan initiative to fight illegal actions being taken by the executive branch. - Elder Parole
- ERIC Central, Multi-State Database of Registered Voters
- Financial Support for the Public Campaign Finance Board
- Financial Support for Local Boards of Elections
- Proposed Changes to Discovery Rules (Kalief's Law)

Once the state budget is approved, the committee will schedule new appointments to discuss non-budgetary policy issues with our state lawmakers.

Book Review: The Privatization of Everything

One description of the ways that our nation is divided is the emphasis on "me" vs "we." This can be worded in many different ways. In *The Privatization of Everything*, by Cohen & Mikaelian, they use the term "citizen" for those who recognize the value of public goods and "consumer" for those who prioritize things that benefit themselves rather than the community as a whole. As they say:

"A consumer should never pay for a service he does not use. Citizens, on the other hand, agree to pay for services they do not directly use because they can see how they benefit all of us, and they see the indirect benefit to themselves. As citizens we realize that even if we never set foot on a city bus, the fact that others do alleviates congestion, reduces air pollution, benefits the economy by getting people to work, and benefits all of us by getting the people we rely on – the bank worker, the dry cleaner, the barista, or our mother's caregiver – to their jobs. So it is something that *all* citizens benefit from subsidizing. A consumer may not see that, but it is obvious to citizens."

The book goes on to give many examples of public goods like healthy food, clean water, quality education, criminal justice, parks, libraries, and scientific progress that have been recognized as just that – public goods – which are increasingly being privatized, moved out of the public realm to control by profit- making enterprises to the detriment of society as a whole. They also highlight episodes of resistance that have successfully reversed this trend.

I find this formulation well reasoned, well presented, and useful in deciding when and how to push back on the forces of privatization.

May 15: "Art of Power" by Nancy Pelosi


