

## **President's Letter**

#### What Do You Do in a Constitutional Crisis?

That's the question that League members are grappling with. I'm going to share some of my thoughts. My brilliant insight is that we as citizens and as the League need to keep doing things we've always done, do some things we haven't always done, and support groups doing things we in LWV-RMA cannot do.

#### THINGS WE'VE ALWAYS DONE

#### Make politics work better

- The League's bread and butter is helping foster an engaged and informed electorate, via voter registration, Vote411, candidate debates, educational forums, and Get Out the Vote. This agenda is more important than ever and we must do it better than ever by working in new coalitions. There are certain emphases we should add.
- Elect candidates who will use the power of the legislative branch to resist the unprecedented usurpation of power by the executive branch. We have checks in the Constitution but they're only as real as the legislative branch makes them. We can't survive too many cases like Senator Bill Cassidy, MD, who voted to approve RFK Jr., despite suffering obvious discomfort at the idea of a Secretary of Health who doesn't believe in vaccinations. Rating candidates on their willingness to stand up to bullies should become a new thing.
- **Keep pressure on already-elected officials** to carry out their sworn Constitutional commitments even if it means standing up to the president. The cuts to healthcare written into the budget last spring will obviously hurt a large swath of Americans. Citizens have made their feelings known. So far, the main effect has been the end of town hall meetings where people could speak out. We need other creative tactics to keep up the pressure.
- **Build civic engagement at every level.** Citizens must pay attention to how well our elected officials and our governments serve us, all the way from the supervisor of highways who hires his friends for plowing contracts, through the mayor's office who hid killer police, and the county exec who used county employees to remodel the homes of her friends. We all need to practice paying attention and reject malfeasance, always, without delay.

## What Do You Do in a Constitutional Crisis?

#### Support organizations using the courts to fight executive overreach

There are so many abuses of power going on, it takes a website to keep up with people suing the president or various government agencies. On the day I wrote this, there were 222 active cases. Last week it was 190. Mostly the plaintiffs win, which is good. The Supreme Court has weakened the interim measures of the lower courts, but few cases have made it through the appeals process to be fully argued and I remain optimistic. We owe a huge debt to those willing to sue over issues such as:

- Federal override of state election powers
- Elimination of birthright citizenship
- Cutting of departments and programs created and funded by Congress
- Federalizing of state national guards
- Setting of tariffs without Congressional action
- Cancelling of grants & contracts retroactively
- Firing of people from independent agencies such as the Federal Reserve

#### THINGS WE HAVEN'T ALWAYS DONE

#### Participate in mass uprisings

We've learned from Erica Chenowith's work that if we can get 8.5 million people to actively participate in rising against the wannabe-dictator, we're sure to win. The No Kings protests show that we're well on the way. In Monroe County, we need 26,327 people actively and visibly involved in resisting the constitutional crisis. I think we can do it. After all, an estimated 10,000 people attended October No Kings rallies in Monroe County. This is more than a third of our goal and we are just getting started.

#### Resist

My new favorite author is Srdja Popovic, one of the leaders of the Serbian uprising that defeated Slobodan Milosŏvić. See his book, *Blueprint for Revolution*. Here are a few insights I've picked up from this page-turner:

- People are afraid to stand up to power, but no oppressive regime has enough power to put down resistance if enough people are resisting.
- We must not self-censor or self-repress, which is the only way we can lose.
- Start with something small. Protests are an easy entry point, but postcarding to districts with voter purges is good and so is donating to candidates willing to stand up to the President, or boycotting companies that don't.

#### **Encourage defections**

The way we defeat the would-be king is to erode his support..

- All over the world, dictators have fallen when the police refuse to shoot into crowds because they see the crowds are full of people who look like their own families.
- Help the people who prop up the regime realize that their interests aren't truly
  aligned with a proto-dictator. Members of the Texas National Guard who have spent
  weeks in Washington probably thought they were signing up to save Texans from
  floods and tornadoes.
- For examples of a soft-power erosion of the power of the carceral system, rewatch *Iron-Jawed Angels*, the movie about the Suffragists as they survived hunger strikes in jail.

Demoralizing the employees of the machine of state who didn't envision our current Constitutional crisis when they signed on is not difficult. A dictator needs them to maintain his control, so they are crucial.

#### Refuse to cooperate and thank others who refuse

- Thank our Mayor and City Councilors for standing up for Rochester's sanctuary status. Lend your support when you hear of deportation raids in-process. Ask questions of the Locust Club. Why are they trying to help ICE and the DHS with illegal sweeps? Six state Secretaries of State (including our own) have refused to turn over voter lists to the Department of Justice. Thank you, Letitia James, for protecting New Yorkers' sensitive personal information from federal witch-hunts.
- Kudos to teachers for resisting orders to implement school curricula that violate the Constitution. Schools should not be doing religious indoctrination and teachers know it
- Learn about the origin of the boycott (<a href="https://www.irishamerica.com/2025/03/the-boycott-origination-story/">https://www.irishamerica.com/2025/03/the-boycott-origination-story/</a>). Captain Charles Boycott was a land agent who collected rents from tenant farmers in Ireland and evicted those who could not pay. Supporters of a nonviolent resistance movement refused to help. Workers would not bring in his harvests, shops would not sell him food, and workers would not work in the manor house. Captain Boycott left Ireland, never to return, but the tactic spread worldwide.

## Support electoral reforms to reduce the power of parties to punish

Much of our current predicament arises from the power parties have to threaten members of Congress via primaries. Of the ten Republicans who voted in the President's first term to impeach him, the careers of nine of them ended with that vote. The sole survivor is Lisa Murkowski, who benefited from the Final Four election system Alaska first used in 2022. If we were to free our Republican Congressional Representatives to vote their consciences, it could shift outcomes in Congress. The LWVNYS is planning to make those reforms better known.

## **LWVUS Suggested Action**

In a letter to League Leaders, LWVUS has suggested that members take the following action:

<u>Tell your members of Congress to protect the freedom to vote and support the passage of the John R. Lewis Voting Rights Advancement Act (JLVRAA)</u>

Every day, the freedom to vote is under attack. Since the 2013 Supreme Court decision in *Shelby County v. Holder* gutted the *Voting Rights Act* (VRA), at least <u>31 states have enacted 114 voting laws</u> that make it harder to vote, with the burden falling hardest on Black voters and other voters of color.

We need a fully restored VRA to defend our democracy and protect the freedom to vote. That is why the League is proud to support the reintroduction of this vital legislation that is needed to fully restore and modernize the VRA and ensure that discriminatory voting policies are stopped in their tracks.

Equality — and our democracy — cannot wait.

(The key message to our representatives is above, but members should put the message in their own words.)



## **Vote for Your Neighbors: The Importance of Local Elections**

Voting in local elections is an act of caring for our village, town, and neighborhood. It is a way of choosing who will make decisions about our schools, public safety, local taxes, community programs, infrastructure, and the overall quality of daily life.

Local officials control a surprising amount of our everyday experiences. School board members determine educational policies that shape our children's learning environments. Town supervisors and city council members decide how to allocate funds for road repairs, libraries, community centers, and emergency services. Even seemingly small decisions—whether a crosswalk is added near a park or how community policing is implemented—are made at the local level. These choices are not abstract. They affect how safe our streets feel, how supported our youth are, and how welcoming and functional our community becomes.

When we choose not to vote locally, we leave these decisions to a handful of people rather than engaging in the collective care of our community. Low voter turnout in local elections means that a small fraction of residents are shaping policies for everyone. In some cases, decisions that impact thousands are made based on the votes of just a few dozen people. This imbalance does not reflect apathy alone; it reflects a misunderstanding of how powerful local elections truly are.

To vote in local elections is to say, "I see you" to our neighbors. It is a commitment to shared responsibility and a recognition that democracy begins on our own street. Just as we would speak up if a decision affected our household, voting ensures that our household—our village—is heard.

In nurturing our community through local voting, we are not just participating in democracy; we are practicing care. Like family members who look out for one another, casting a ballot for local candidates is a way of investing in the well-being of those closest to us. In uncertain times, it is an act of hope and solidarity. To vote for your neighbors is to believe that what happens on your street matters—and that your voice does too.

## **Outreach to New Americans Committee**

The Outreach to New Americans Committee has been busy as we approach Election Day 2025. The committee's activities included:

- Mailing 70+ postcards to newly naturalized citizens congratulating them, providing information, and encouraging them to get out to vote in this fall's election.
- Giving presentations on voting to three online English language classes through Catholic Charities Family and Community Services of Rochester.
- Attending one citizenship class offered through the Maplewood Public Library.
- Distributing posters in English and Spanish that provided information on voting dates and sites to local community centers, churches, and libraries.
- Connecting with the Rochester Refugee Resettlement Services to explore collaboration to help some of their clients pursue citizenship and become voters.
- Tabling again with the Service Employees International Union (SEIU) members at Strong Memorial Hospital for their FUNDS Day on October 23<sup>rd</sup>.
- Finally, tabling at International Plaza's Market Day on September 28<sup>th</sup> and returning to the Plaza for their Trunk and Treat celebration on October 25<sup>th</sup>.

#### **LWVUS Joins Amicus Brief Submitted to US Supreme Court**

In September, the League of Women Voters (LWV) and Common Cause, alongside Campaign Legal Center (CLC) submitted an <u>amicus brief</u> to the US Supreme Court, which urges the Justices to uphold party coordinated spending limits in the *National Republican Senatorial Committee (NRSC) v. Federal Election Commission* case.

#### Below is the the joint September 30th press release:

"The National Republican Senatorial Committee (NRSC) is challenging critical, long-standing limits on how much money political parties can spend in "coordination" with federal candidates. The US Supreme Court upheld these limits in 2001 as an important barrier to preventing donors from funneling massive amounts of funds to the candidates of their choosing through political parties.

A key principle of campaign finance law, reinforced by the Court, is that an expenditure that is "coordinated" with a candidate is functionally the same as a contribution given directly to the candidate. Therefore, limits on both are important to preventing quid pro quo corruption in our federal elections.

"What's at stake in this case is the very integrity of our elections," said Celina Stewart, CEO of the League of Women Voters. "Lifting limits on coordinated party spending would open the door to more corruption that ultimately allows big money to drown out



the voices of everyday Americans. In a time when money already plays an outsized role in our politics, removing this safeguard would be yet another step towards total deregulation of campaign finance. The League proudly supports this limit as a crucial protection for fair and accountable elections."

CLC first filed an <u>amicus brief</u> with Citizens for Responsibility and Ethics in Washington (CREW) in support of federal limits back in 2024 in the US Court of Appeals for the Sixth Circuit. That court <u>upheld</u> these limits last year.

Now the Supreme Court will decide whether to maintain its own 2001 ruling in *FEC v. Colorado Republican Federal Campaign Committee* — known as the "Colorado II" decision — that affirmed the constitutionality of these limits. At that time, the Court expressed concern that removing these limits would provide donors with the opportunity to bypass individual contribution limits by funneling larger sums through the parties in order to buy influence with candidates and officeholders.

Voters need to have confidence that wealthy special interests cannot simply buy influence and political favors by routing big contributions through political parties. Our nation's highest court should affirm the limits on coordinated spending by political parties in order to protect our democracy. "

## **Antoinette Brown Blackwell Society**

LWV-RMA President Barbara Grosh spoke at the Antoinette Brown Blackwell Society on October 16, 2025.

She explained LWV's mission, "Empowering Voters, Defending Democracy."

She shared current issues surrounding voting, promoting registrations, and educating voters.

Addressing the country's current Constitutional crisis, she recommended that we be optimistic and involved, and prepare for a marathon.
