President's Letter

Electoral Reform in Rochester

We're doing it! We're going to try to get a charter amendment passed to bring Ranked Choice Voting and All-Access Primaries to Rochester. That was the consensus we reached at our annual advocacy meeting on Jan. 31. The task is daunting, but we decided that there is a lot of energy to do something to improve our democracy, so the time is right. Whether we succeed or not, we will make the issues better known and make legislation at the state level one step easier. If we succeed, we'll put Rochester in the forefront of reform in NY! Both Susan B. Anthony and Frederick Douglass worked for universal ballot access, so we felt inspired by our ancestors' examples to do something ambitious.

Our first step will be to nail down the language we will propose. We're looking at language elsewhere and getting input from our partners at UniteNY. On Feb. 11 we'll hold a webinar to look at what's in the charter now, look at the suggestions and maybe wordsmith. Invite your friends with legal language insight and an appetite for making change! Put the [webinar on your calendar](#).

Here's an outline of the process for the next year:

- Finalize language by mid-February
- Collect 4,107 signatures on petitions beginning by late February. We'll work to get political campaigns to pass our petitions while they collect signatures to get on the ballot, but we'll also think of ways to target voters not registered as Democrats, who have the most to gain.
- We'll need allies all over the city to help collect signatures and spread the word.
- We'll submit our signatures as soon as we collect enough, aiming for May. The signers must be registered voters who reside in Rochester.
- After we submit the petitions, the proposal will go to City Council. If they approve it, it will be placed on the November ballot. If they don't approve it, an additional 2,054 signatures will be needed to get on the ballot. The deadline is Sept. 1 to get on the November ballot.
- Keep publicizing until election day!

Ranked Choice Voting and All-Party Primaries in Rochester Forum

On January 20, the LWV-RMA hosted a discussion on Ranked Choice Voting (RCV) combined with all-party primaries. We were joined by David Green, Organizing Director for Unite NY, a good-government non-profit the League has been working with on various electoral issues.

The LWVNYS last year adopted a position in favor of amending state election law to use RCV combined with all-party primaries to govern elections statewide. We'll be working towards that, but it could be a while before that comes to pass.

Home rule in NYS allows cities to amend their charters and change how *city offices* are elected. Unless towns, villages, or counties have specific election laws for their offices, the state laws govern. Therefore to change the voting processes in those areas either:

- The NYS Legislature needs to pass the changes which the towns, villages, and counties could opt out of if they wished, or
- Each town, village, or county needs to pass its own laws


Some Leagues in NY are moving ahead, proposing city charter amendments to bring those reforms to their cities. Rochester has been proposed as a logical city to do this. By implementing these changes for city offices first, it is hoped that more people would become familiar and comfortable with the process, therefore making it easier to change the state election laws.

The meeting covered how all-party primaries and RCV works and how they might affect the governance and politics in Rochester. The potential for eliminating primaries altogether and implementing RCV at the general election was also discussed. There would definitely be financial benefits for both the candidates and the city if that option is implemented.

Raising Citizens

League members met via Zoom on January 13 to discuss "Raising Citizens" with Lindsey Cormack, PhD, Associate Professor of Political Science, Stevens Institute of Technology in Hoboken, NJ. and author of *How to Raise a Citizen (And Why it's Up to You to Do It)*. She also created and maintains the digital database of all official Congress-to-constituent e-newsletters, *DCinbox*, at <https://www.dcinbox.com/>.

Dr. Cormack noted that:

- * NYS is the fourth lowest state in the number of 18-24-year-olds registered to vote.
- * Most high school students taking the AP US Government and Politics course do not earn college credit.
- * The percentage of people voting increases as their age increases, so younger voters are not as well represented.
- * There is a tradition of not talking about politics in social situations.
- * Because of federal and state mandated testing programs, schools focus more on reading and math.
- * Court cases and parental pressure and threats of lawsuits have led K-12 educators to avoid any issues that might be deemed controversial.

Dr. Cormack offered a number of strategies to help raise active, contributing citizens:

- * Remember that raising a partisan is different than raising a citizen (like the difference between a fan and athlete).
- * Parents model behaviors that their children absorb.
- * Children do politics among themselves, and are capable of learning more.
- * No one likes playing games when they don't know the rules.
- * Practice is critical. Parents can provide experiences for direct involvement, taking children when voting, to government spaces and meetings, and to meetings with lawmakers.
- * Emphasize the good that the government does for the community (roads, water, snow plowing, fire prevention, and financing programs for health and education).



Google Grants

Google offers grants for up to \$10,000 per month to 501(c)(3) non-profits for free Google "ads." It is easiest to think of it as a way to advertise LWV-RMA as a valid source of information. For example, if someone searches in Google, "In NYS how do I register to vote" one of the first results would be a link to our web page where there could be a video and words explaining the process. The questions and results can be targeted to specific geographic areas. The LWV-RMA Board of Directors sees this as another way to provide relevant information to voters and potential voters.

Elevation is a company that works with non-profits to apply for and utilize the Google grants. They provide guidance for structuring the "ads" and provide tools to measure the success of the program. The LWV-RMA Board has signed a one-year agreement with Elevation to help us implement this program. The new media team (*see page 6*) will be developing related materials for the website. 2026 Legislative Priorities

Let New York Vote is a nonpartisan, statewide coalition of grassroots networks, civil rights and civil liberties organizations, re-entry communities, good government groups, unions, social service providers, immigrant rights groups, and everyday citizens fighting to improve our elections by making registering and voting more accessible and equitable for every eligible New Yorker.

Priorities to Make Voting More Accessible

- [S440](#) - Sen. Myrie / [A2121](#) - AM Walker: Establish the election infrastructure to make voting accessible for all **those eligible to vote who are detained in jails**.
- [S2056A](#) - Sen. Webb / [A3954A](#) - AM Raga: Expand civic engagement practices for students by enacting a **Student Voter Empowerment Act**.
- [S5851](#) - Sen. Skoufis / [A7369](#) - AM Walker: **Move local elections to even-numbered years**, including city elections (requires a constitutional amendment).

Priorities to Improve Voter Registration

- [S5751](#) - Sen. Gianaris / [A2162](#) - AM Carroll R: Expand same day voter registration to every day of in-person voting through **amending the New York State Constitution**.

Priorities for Voter and Election Protection

- [S4602A](#) - Sen. Gounardes / [A5846A](#) - AM Gibb: **Extend time for polling place disruptions**, where an emergency or other disruption to voting lasts more than 15 minutes.
- [S3233](#) - Sen. Kavanagh / [A6354](#) - AM Walker: Require persons that challenge the validity of voter applicants to provide an **affidavit for the challenge**.
- [S7116](#) - Sen. Cleare / [A6287](#) - AM Cunningham: Ensure accessible use of paper ballot through the **voting integrity and verification act (VIVA) of New York**.

LWV-RMA Civic Education Committee Update

On January 7, members and non-members gathered to discuss how LWV-RMA could step up our Civic Education efforts. The 19 attendees discussed various channels that could be used to provide information and decided to focus their efforts on:

- Holding public forums, both in person and via Zoom
- Providing written information to local media outlets
- Developing videos and animations for social media and the LWV-RMA website

The group decided to work in two teams:

- Civic Education Forums, coordinated by Mary Micket
- Civic Education Media, coordinated by Barbara Grosh

As of January 20th one member, Connor O'Brien, had already made an arrangement with the Democrat and Chronicle to publish a monthly article from LWV-RMA on relevant topics. In addition, Connor and Hanna Brandt are working to identify local college students to assist with videos and film editing. LWV-RMA Forum with ReConnect Rochester on Safer Streets

On December 10, two officials from ReConnect Rochester met via Zoom with LWV-RMA members to share the group's mission and recent initiatives. Co-Executive Director Cody Donahue provided an overview of ReConnect programs, including street makeovers, alternate transportation, and safe street advocacy.

Policy and Advocacy Coordinator Henry Litsky focused on efforts to reduce speed limits as a major step in controlling traffic accidents, especially those involving pedestrians. A video shown during the presentation demonstrated how community members near the intersection of Avenue D and Hollenbeck Street helped to identify changes to make that area safer and even created artwork on the street to help slow down traffic. The discussion was moderated by LWV-RMA President Barbara Grosh.

One of their main initiatives is to get cities and towns to lower their speed limits. Rochester and Brighton have already done so, and our members might want to work to get their towns to do so too. The ReConnect Rochester website has extensive data on where accidents happen, to give a sense of what might be gained by lowering speeds. Speeds on county- or state-owned and maintained roads are controlled by the county and state, so that would require a different campaign.

Governor Hochul Signed the League-supported ERIC Bill

Governor Hochul has signed the **Electronic Registration Information Center (ERIC)** bill (S1356A / A3649B). This will strengthen voter protection, election integrity, and election efficiency in New York State.

On December 8, 2025 LWVNYS sent a letter to the Governor, signed by the State League and nearly all of our 40 local League chapters, including LWV-RMA, urging her to sign it as soon as possible. On December 9, the bill was delivered to her and she signed it! Here is an excerpt from the letter explaining the importance of this bill:

"New York's outdated voter list maintenance practices have led to serious consequences, including illegal voter purges, wrongful 'inactive' designations, and widespread issues at polling places. These failures undermine voter access and trust in a time when it's critically important."

ERIC offers a proven, secure, and nonpartisan solution. Already adopted by 26 states, ERIC uses data from state voter files, DMV records, the Postal Service, and the Social Security Administration to help election officials:

- Identify in-state and cross-state movers, duplicates, and deceased voters
- Maintain control of voter rolls and prevent wrongful purges
- Contact eligible but unregistered voters to boost civic participation
- Save time and resources by reducing undeliverable mail and affidavit ballots

This biography details the incredible life of Josephine Baker, the American entertainer who secretly became a spy for the French Resistance and British Intelligence during World War II, using her stardom in Europe and elsewhere as a cover for espionage missions against the Nazis.

The Rt. Rev. Dr. Budde came to national notice for her powerful message of mercy and compassion toward the marginalized during an interfaith prayer service in January 2025, attended by recently re-elected President Trump and other federal officials.
